FROM THE KOMITI PAPA POUNAMU

2023 was a big year...on the one hand we faced unprecedented weather and climate related disasters; on the other we are seeing a new coalition government take power and commit to 100 actions in 100 days, set to undo a lot of progress made to strengthen our system's resilience in relation to future events and planning challenges. The change of government means *"a change of policies and a change of approach"*.

Particularly relevant changes include:

- Repeal the Spatial Planning and Natural and Built Environment Act;
- Introduce a fast-track consenting regime
- Cease implementation of new Significant Natural Areas and seek advice on operation of the areas; and
- Stop all work on He Puapua.



WHAT'S IN STORE FOR 2024

Papa Pounamu in 2024 will focus on strategic national and regional representation and influence.

Papa Pounamu will seek to align with and support other Māori interest collectives and forums, including:

Ngā Aho - national network of Māori design professionals

Te Pū Oranga Whenua - kaupapa Māori Agribusiness collective redesigning land use and development in a way that works for whānau.

Ngā Kairapu - Regional Sector Special Interest Group.

AHAKOA HE ITI HE POUNAMU

This simplified illustration conveys the potentiality of a **dual planning paradigm**, which has been advocated for by Māori planning scholars such as Professor Hirini Matunga for decades. Kaitiakitanga is much more than a discipline or practice. This graphic is a small reminder of the depth and power of Te Ao Māori and the immense value and significance of our ethics of care (i.e. ‘kaitiakitanga’).

Take pride and confidence in being a Māori practitioner or an ally that honours Te Tiriti and works alongside us. Te Ao Māori is a koha that has the potential to benefit all Aotearoa.

Western science has the potential to operate alongside mātauranga and tikanga, where the two co-exist in shared spaces within Te Ao Mārama. Planning and practice that is respect-full, care-full, and operates in aroha has transformative power.

Only Tāngata Whenua can draw on our whakapapa and the deep mātauranga and tikanga evolved over time, specific to people and place, and to inform contemporary management and innovation today.

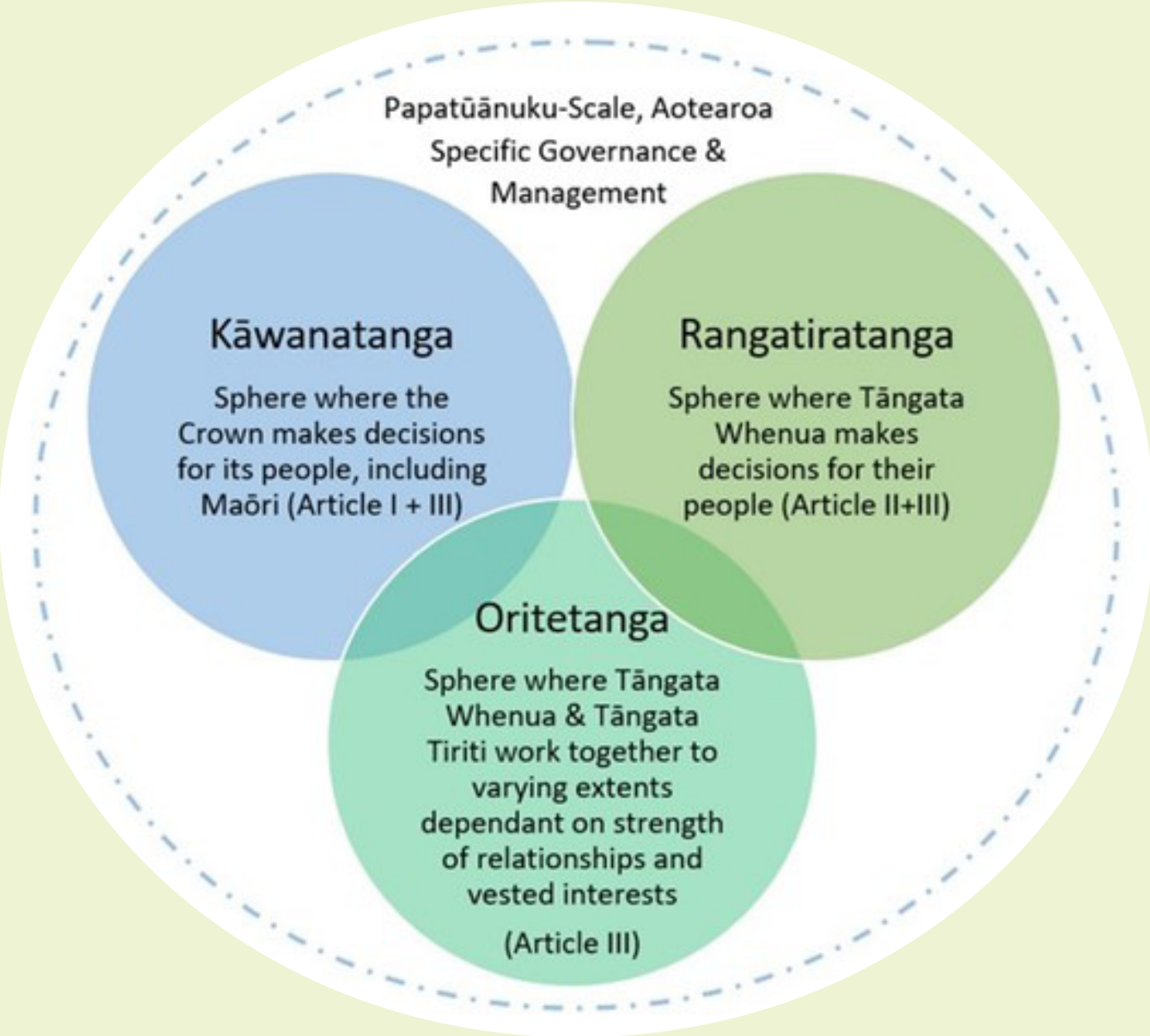

PUTTING PAPATŪĀNUKU FIRST



In hindsight, while the reformed system remained less than ideal for giving effect to the mana and rangatiratanga of iwi and hapū, the Natural and Built Environments Act and the Spatial Planning Act did offer greater impetus for putting Papatūānuku first, particularly via the overarching purpose to uphold Te Oranga o te Taiao.

Similarly the Water Services Entities Act offered greater potential for addressing the complexities of three waters, and the inclusion to give effect to Te Mana o te Wai in both the Water Services legislation and the National Policy Statement for Freshwater Management seemed promising.

We acknowledge Jade Wikaira (a former PP Chair) and her involvement in the Randerson Panel; the work of Tina Porou, Maia Wikaira, and the Iwi Chairs Forum; and our many Māori planning members and allies, who worked tirelessly for adequate recognition and provision for Tāngata Whenua and a Tiriti-based system...

There’s still more work to be done and we look forward to working together in 2024.

Regardless of ‘politrics’ or the government of the day’s position, **we see a Tiriti-based future that celebrates our pluralism.**

The planning profession has work to do to realise a

much-needed whole systems approach for Aotearoa, aligned with the Spheres of Influence framework imagined in the Matike Mai Constitutional Transformation Report 2016 (informed by 252 Hui across Aotearoa): the Rangatiratanga, Kāwanatanga, and Oritetanga Spheres of Influence.

Our policies, plans, and practices must acknowledge and enable rangatiratanga, mātauranga, and tikanga - all three simultaneously comprise and activate kaitiakitanga. To see a more hopeful trajectory for our planet and mokopuna, they can not be applied piecemeal or adhoc.

INSIGHTS IN 2023 INFORMING PRIORITIES FOR 2024

**Māori resistance is critical to
Māori resilience.**

**Water | Food | Energy security and
sovereignty are critical.**

**Ensuring Rangatiratanga, Mātauranga,
and Tikanga at the appropriate scale is
critical (a-iwi/hapū/whānau).**

Aotearoa needs a planning framework that puts **Papatūānuku first**. Councils, corporates, and communities can do this regardless of the provisions (or lack of) in the system of the day.

Te Oranga o te Taiao is inseparable from and critical to the health and wellbeing of our communities and whānau.

Te Mana o te Wai exists whether the government recognises it or not. We will continue to operate in aroha and mana-enhancing ways.

What's good for Māori is good for everyone. But what is good for everyone is not necessarily good for Māori.

We will continue to **say no to the status quo.**
